#### 2021 Accomplishments:

- The trailer at the dumpster area was rebuilt.
- Continued vinyl siding initiative on the lower level (3 Units).
- Cleaned gutters throughout the community.
- Repaired broken sewer and water lines.
- Repainted the parking areas throughout the community.
- Minor repairs were made throughout the community on general maintenance items such as screens, lights, roofing, pressure washing, replacing retaining wall caps, etc.

### 2022 Goals:

The goal is to complete the final 5 unit fronts and 5 unit sides on the lower level with vinyl siding.

- We hope to begin the first of four stages of landscaping on the hill at the villas; stage one will cover from beside Unit 429 to the front of Unit 366.
- All 8 decks that are the responsibility of the HOA will be replaced with a low maintenance, composite decking material. This initiative will cover the back decks from Units 23 to 29 and Units 423 to 429.
- Other maintenance and minor repairs will be addressed on an "as needed" basis.

### Other items:

• Lawn maintenance will continue with One Earth Landscapes at \$750 per cut; this expense is a reduction from what Alluring Landscapes invoiced the community.

## Scot Finley reported:

- The Board has opened an annuity with Trust Bank on October 11, 2021; the amount invested was \$50,000.00 at a 2.25% interest rate.
- An update was given on OPN Law collecting unpaid HOA fees.

The next meeting will be held at 7pm on December 21, 2021 at Cloverdale Church of the Brethren.
