Cary Hunley reported:

- > The COVID-19 pandemic continues to present challenges to our community; three of the biggest challenges have been the inability to hold bi-monthly meetings, the increasing expenses for trash removal, as well as excessive lead times for building materials (ex. vinyl siding, vinyl accessories, shutters, etc.)
- We will hold the Annual Meeting on November 10, 2020 at 7pm at Cloverdale Church of the Brethren. The COVID-19 restrictions set forth by the Governor will be in place. Every attempt will be made to shorten the presentation to limit exposure.
- Currently working on the Budget for 2021. As stated prior, there will be no dues increase and no special assessments in 2021.
- All 5 positions will be up for election during the November meeting.
- > The goal will be to complete the vinyl siding fronts up to Unit 236 by the Annual Meeting in November. Currently, we are waiting for more siding and shutters to arrive. We hope to complete the vinyl installation on the fronts of all of the units on the lower level by the end of 2021.

Glenn Dudley reported:

- > The Board has received complaints of children riding scooters and bikes on sidewalks; we ask for the parents to be involved to make sure their children are abiding by the rules and respecting others property.
- > A meeting with Alluring Landscapes will be taking place regarding snow removal and our expectations during the winter season.
- > Spot gutter cleaning, spot pressure washing, and the completion of vinyl siding front to Unit 236 will wrap up the initiatives for 2020.

Scot Finley reported:

- > A check for \$7,833.00 was received from the Estate of Myrtle Dalton, Unit 220, to pay the amount owed for the outstanding dues.
- A court date has been set in November for the last remaining unit that has a large balance in arrears.
